
21 OCT - DAY 1: TEL AVIV - CAESAREA - MT CARMEL - GALILEE

We start our tour at Ben Gurion Airport in Tel Aviv, and meet with our friendly local guide and bus driver. The group shuttle will depart from the airport at 10am sharp - so please ensure you are waiting at the Ben Gurion arrivals hall at this time. If you are late, you will need to make your way by taxi to the hotel in the afternoon.

The group will depart for **Caesarea**, where we visit the restored Roman Amphitheatre, the remains of a Crusader Fortress and a Byzantine Street. Caesarea was home of the first gentile convert, Cornelius a Roman Centurion baptized by Peter (Acts 10). After a stop for lunch, we continue to **Mt. Carmel** and visit the site where Elijah had the confrontation with the Baal prophets (1 Kings 2 v15) and the battle of **Armageddon** will take place. Check in at our **seaside hotel on the shore of the Galilee**.

22 OCT - DAY 2: SEA OF GALILEE BOAT & CAPERNAUM - JERICHO - DEAD SEA

This morning after breakfast we cross the **Sea of Galilee** by boat to **Capernaum** (the city of Jesus) after a time of teaching and worship on the Lake. Thereafter we head to the **Mountain of Beatitudes** where the Sermon of the Mount (Matt 5-7) was delivered. Our next stop is at the Lake shoreside, **Mensa Christi**, where Peter was recommissioned (Jn. 21). After lunch, our final stop for the day is **Yardinit** where the **Jordan River** flows from the Sea of Galilee. This spot marks the traditional place where John baptized Jesus. Here a **Baptismal service** will be held. Return to your hotel for dinner and overnight.

23 OCT - DAY 3: NAZARETH VILLAGE - CANA - TIBERIAS

This morning we visit **Nazareth Village** - a Galilean Village, recreating Nazareth as it was 2 000 years ago. As you walk the dusty streets, you will begin to imagine life in another time - when Jesus lived here. After a wonderful morning of teaching and worship, we head for a tasty local lunch. Hereafter we continue to **Cana** to see where Jesus performed His first miracle; in the chapel we will conduct a special marriage vow renewal ceremony. Next we visit **Jericho*** - the city destroyed by Joshua. Here you will view the **Mount of Temptation** where Jesus spent time in the wilderness and enjoy a local lunch. Our journey continues to the **Dead Sea** where we will swim (or rather float!) in the salty mineral waters. Check in and dinner at our **desert oasis resort hotel** for the night.

24 OCT - DAY 4: MASADA - QUMRAN - JERUSALEM

This morning after breakfast we drive to **Mount Masada**. On arrival, we ascend the mountain by cable car , where we will view the ruins of a Jewish Fortress (967 Jews committed mass-suicide rather than surrender to their Roman besiegers). Next we stop to visit the **Qumran Caves**, where the Dead Sea Scrolls were found. After viewing the caves, we will have the opportunity to shop at this Kibbutz and have lunch. We continue up to **Jerusalem**, the Eternal Capital city of Israel where we check in at **our deluxe hotel in Jerusalem near the Old City**. After dinner, a **special evening outing** has been arranged for the group to in the ruins of the City of David - situated **close to the Jaffa Gate**.

25 OCT - DAY 5: MT OLIVES - GETHSEMANE - MT ZION

This morning we explore the **Mount of Olives** with its beautiful view over Jerusalem. We will visit the Church of Ascension (where it is believed Jesus rose again to Heaven) and then the Pater Noster Church where Jesus taught His disciples "Our Father". After a group photo and perhaps a camel ride, we walk down the slopes of the mountain to **Gethsemane** where we will take in the beautiful view over the Old City and the **Golden Gate**. We end at the **Garden of Gethsemane** where Jesus prayed the night before His crucifixion (Luke 22:39) - the same place where Peter cut off the ear of the high priest's servant (John 18:10). Here we arrange a special **private prayer service** in the Garden (Exclusive to JOY! Travel and this tour).

After lunch, we drive to **Mt Zion** and visit the **Church of St. Peter in Gallicantu**, also known as the "Church of the Cockcrow", where Peter denied Jesus. Continue to the **Upper Room** of the Last Supper. Our tour includes the **Tomb of David**. We finish for the afternoon at our hotel.

26 OCT - DAY 6: OLD CITY - WESTERN WALL - VIA DOLOROSA - FREE TIME

This morning is a walking tour through the **Old City** as we enter through the ancient gates. We walk to the **Western Wall**, the holiest site for the Jews where we have some time to pray at the famous site. Next we stop at the **Pool of Bethesda**, as we follow the **Via Dolorosa**, and stop at the various stations of the Cross. Thereafter we will have free time for shopping and lunch in the market. Proceed to our hotel.

27 OCT - DAY 7: FRIENDS OF ZION MUSEUM- BEN YAHUDA STREET - BETHLEHEM

This morning, we head to the **Friends of Zion Museum** - an amazing interactive digital museum experience that will close off your tour perfectly. Next you will have some free time in the famous **Ben Yahuda street** for shopping and people watching. We then cross the **city to Bethlehem** where we will have **lunch in a tented Bedouin restaurant** and we finish the day at the **Shepherd's Fields** where a special service will be held.

28 OCT - DAY 8: GARDEN TOMB - GOLGOTHA - MODEL OF THE OLD CITY - TEL AVIV

This morning we visit the **Garden Tomb** next to **Golgotha**, where a **Communion Service** will be held, one of the highlights of your tour. Next we head to the **Israel Museum** to view the **Holy Land Model**, a giant scale model of Jerusalem at the time of Jesus. We proceed to **Tel Aviv (Ben Gurion airport)** where clients will catch their return flight home after a memorable and life-changing Israel tour.

Joy Christian Travel (PTY) Ltd, their associated companies and agents including Christianity Works, and all persons, parties or organizations acting on their behalf or in collaboration with them, and all group leaders (hereinafter referred to as "the Organizing Agent") give notice that:

1. In issuing or obtaining the issue of any ticket or coupon, on making any arrangement for transport or conveyance, or for accommodation, the Organizing Agent act as agents only, and shall not be liable as principals.
2. The Organizing Agent shall be entitled to make any arrangements for the issue of any ticket or coupon or for transport or for conveyance or for accommodation as they in their entire discretion may deem advisable.
3. The Organizing Agent shall not be liable in any circumstance whatsoever and whether in contract or deficit for any damage, injury (including death), loss, delay, or inconvenience of any sort whatsoever which shall be caused to any passenger, whilst on tour or for any alleged failure by the Organizing Agent to make satisfactory or any arrangements and whether caused through the act of default of any for the servants, agents or sub-contractors of the Organizing Agent.
4. Each passenger agrees that he, his heirs, executors, administrators and/or assigns shall indemnify the Organizing Agent, its servants and agents from and against claims for damage from any cause whatsoever to any person who may make a claim against the Organizing Agent or any of them, whether for loss or damage to property in the custody of a passenger, whether or not such a claim is based on the negligence of the Organizing Agent, its servants or agents or any sub-contractors of the Organizing Agent.
5. All arrangements are subject to the law of the country where the conveyance of hotel or other service is to be provided.
6. All prices are from the departure point indicated in the tour programme and based on prices and rates of exchange ruling at the time of preparation of the document in which the quotation is made and is subject to increase without notice. All prices quoted are per person sharing accommodation.
7. Tours are planned on the basis of twin bedded rooms and where for reason beyond their control, the Organizing Agent cannot accommodate any participant on this basis, the passenger will be obliged to pay the supplement for a single room unless he/she can arrange with two other passengers of the same sex to share with them a three-bedded room. In the event of a three-bedded room being used, the tariff for twin-bedded accommodation will apply.
8. The Organizing Agent reserves the right to exchange the listed hotels (at their discretion) with others of the same quality or a better category, at no extra cost to the passenger.
9. The tour price is based on airfare and tariffs for hotels and land arrangements as well as international rates of exchange available at the time of preparation of the tour program. The tour is subject to any alteration in final costings to the above; tour members will be advised of such changes, if any at the time of final group payment deadlines. Land arrangement payments abroad will only be done once all the monies have been received by all the tour members.
10. Attention is drawn to the frequency of changes in official timetables and passengers are urged themselves to verify any times of departure shown in any programme or itinerary.
11. Passengers are reminded that luggage or personal property taken on tour is at owner's risk and passengers themselves are advised to insure it unless already covered in their travel insurance cover. Personal accident and sickness insurance are not automatically included, or if otherwise indicated on your travel programme.
12. The Organizing Agent is not to be held responsible for any act, omission or event during the time passengers are not on board their aircraft. The Organizing Agent further accepts no responsibility or liability if the passenger is denied boarding for whatever reason (including but not limited to: failure to meet security checks, failure to meet health checks such as elevated temperatures, failure to produce relevant documentation etc). The passenger tickets in use by the airline, when issued, shall constitute the sole contract between the airline and the purchase of these tickets and/or passenger. Passenger is required to check that their passport is valid for time of travel with a minimum of 3 blank pages (or as per country rules).
13. The Organizing Agent cannot be held responsible if entry to any country is denied for any reason, nor can we be held responsible for any change of requirements, delays or loss of passport caused by the embassies concerned.
14. Visas can be arranged by our office on behalf of the passenger. It is the responsibility of the passenger to courier all relevant documentation to our office, in enough time, and to peruse the corrected information thereof. The Organizing Agent does not accept any responsibility for incomplete visa forms, or visas wrongly issued by the embassies or visas not issued in time or visas denied. Should a visa be denied for a tour for any reason and the passenger can no longer travel, the Organizing Agent reserves the right to retain all monies paid over for travel by the passenger.
15. The Organizing Agent accepts no responsibility for any documents lost, either in the post or by courier.
16. The Organizing Agent cannot hold themselves responsible or be held responsible by clients for the obtaining of refunds on loss or unused tickets, coupons or vouchers, although every effort will be made to claim settlement on behalf of passengers.
17. All deposits and tour monies are payable to Joy Christian Travel (Pty) Ltd, we will not take any responsibility for payments done to a third person. A booking is only confirmed upon receipt of a deposit and signed registration form. Clients are liable for cash deposit fees and/or any other bank charges for international transfers. Credit card payments are not advised however should a client pay by credit card they are liable for the bank charges and merchant fees for each payment transaction.

Please respect the payment deadlines given.
19. The Organizing Agents reserves the right to cancel any passenger from a tour with immediate effect, in the interest of the tour group. A passenger that is disruptive to the tour will be asked to leave the group and no refund or partial refund will be issued for any expenses arising from such decision.
20. The Organizing Agent accepts no responsibility for passengers who incur medical expenses or lose their property on a tour.
21. The Organizing Agent reserves the right to cancel or abandon the tour if the minimum numbers of participants are not met. In such event, any monies paid will be refunded, less any expenses, disbursements or other commitments incurred by the Organizing Agent on behalf of the passengers, and in such event the Organizing Agent will accept no further or other liabilities. The right is further reserved to modify an existing tour in any way they deem advisable.
22. In the instance of the Organizing Agents postponing a tour due to Force Majeure (including but not limited to a pandemic, terrorist incident, travel ban etc) clients will be offered a new postponement date or voucher for travel as per the terms and conditions of the airlines and hotels.

Should the passenger insist on a cash refund, this will be at the discretion of the suppliers, and will be subject to an additional administrative handling fee determined by the suppliers and Organizing Agent at the time of refund request at a minimum cost of 10% of the tour retail price. No refunds will be issued unless the Organizing Agent is able to secure the funds from the various third party suppliers.

23. The Organizing Agent will not be held liable for any changes to refund or voucher policies of the hotels, airlines or travel insurance company which may be changed without prior announcement by the suppliers.
